The Junction Farmers Market (JFM) provides local, sustainably produced fresh foods in ways that build our community, support local food growers and producers, and promote access to healthy food for everyone who lives in and around the Junction. Each week, the JFM relies on the support of its volunteers to make this vision possible.

By accepting a volunteer position with the JFM, you must agree to the following understanding with the Junction Farmers Market:

### **Punctuality**

Volunteers will arrive on time for their shift. If a volunteer is unable to make their shift, they will inform the Market Manager as soon as possible and adjust in SignUp forum.

### **Respect**

Volunteers will treat market patrons, vendors, guests, and fellow volunteers respectfully. Likewise, volunteers will be treated with equal respect, free from discrimination of any and all forms. Everyone is welcome at the JFM!

### **Accountability**

If a volunteer does not know the answer to a question or how to handle a certain situation, they are encouraged to ask the Market Manager for guidance at any time.

### **Attire**

Volunteers will wear family appropriate attire, and we suggest comfortable, protective shoes. They will also wear their volunteer pins and orange aprons so that all who attend the market can readily identify them.

### **Eating and Drinking**

If you wish to eat while on your shift, we encourage you to do so discreetly, neatly, and in a way that does not interfere with your volunteer duties.

Summers in Toronto can be sweltering. Remember to keep yourself hydrated throughout your shift. Volunteers are encouraged to bring a reusable water bottle with them which can be filled on site.

### **Smoking**

We want to promote a clean environment here at the JFM. Volunteers will refrain from smoking on the JFM grounds.

### **Media Release**

The volunteer's activities may be documented in the form of photographs, video, or interviews for promotional and not-for-profit purposes only.
